Fixed Route Bus Service

STS provides fixed route bus service to many areas of Schuylkill County. These fixed route buses pickup and discharge passengers at regular designated bus stops and times. The hours of operation include Monday thru Friday 6:00 A.M. until 5:00 P.M. Saturday service is provided 8:00 A.M. until 4:00 P.M. Senior citizens 65 and older are eligible for the free transit program through the Pennsylvania Lottery Program. ADA Para Transit Shared Ride Van Program

The Schuylkill Transportation System is pleased to provide accessible bus service to persons with disabilities, fully compliant with the requirements of the Americans with Disabilities Act (ADA). For more information on ADA para transit services and how you may qualify, call STS at 1-800-832-3322.

STS Shared Ride Van Service

STS Shared Ride Van Service provided curb to curb transportation services for ambulatory and non-ambulatory Schuylkill County residents to points within the county. A minimum 24 hour advance reservation is required.

Medical Assistance Transportation Shared Ride Van Program

Medical assistance ACCESS cardholders may be eligible for in-county or out-of-county medical transportation for Medical Assistance subsidized appointments. For more information regarding this program, call the Medical Assistance Transportation Program coordinator at 1-888-656-0700 or (570) 628-1425.

Welfare to Work (w2w) Transportation Program

This program funds the transportation of low-income individuals to get to work and child care facilities. Specific guidelines must be met in order to qualify for this program. For more information please contact your local Pennsylvania Career Link at 1-800-359-0941 or (570) 622-5253.

Senior Citizen Shared Ride Van Program

Senior Citizens, 65 & over, can register for transportation services at the following senior resource centers: Tremont, Schuylkill Haven, Pottsville, Shenandoah, and Mahanoy City. You can also contact the Office of Senior Services at 1-800-832-3313 or call STS at 1-800-832-3322. The following trips are subsidized by the Lottery Program and require a \$1.00 co-pay for each one-way trip:

- Medical appointments/pharmacies
- Local grocery shopping
- Senior resource centers
- Social service agencies
- Banks and post offices

Trip purposes other than those listed above can be provided within Schuylkill County for fares ranging from \$2.25 or \$2.40 per one-way trip.

Persons with Disabilities Shared Ride Van Program

County residents, with a disability as defined by the ADA Act who are between the ages of 18-64, may be eligible for shared ride van service to many destinations within Schuylkill County. Registration is required and can be obtained by contacting STS at 1-800-832-3322. The fare for a one-way trip within Schuylkill County is either \$2.25 or \$2.40, depending on the distance needed to travel.

Group Trip Services

Senior Citizens and Persons with Disabilities

STS provides group trip transportation for senior citizens and persons with disabilities to destinations within Schuylkill County and limited out-of-county services to destinations within a 35-mile radius of the county borders. Destination choices are unlimited and some of Pennsylvania's most visited attractions are within the service area of STS. Shopping outlets, malls, recreational facilities and quality dining facilities are just a few of the locations available to you. Service is available Monday through Friday with limited weekend service. Fares are \$2.25, \$2.40, or \$3.45 each way, depending on distance traveled. - ❖ Please remember when scheduling an appointment to inform the operator of any special needs; any changes in your address since your last appointment; the time and date when service is needed and if you will be utilizing the service of an approved escort on this particular trip.
- ❖ Medical and work-related appointments receive scheduling priority.
- ❖ Pick-up times are subject to road, weather and traffic conditions.
- ❖ Child safety seats are required for children on all shared ride van trips.
- ❖ The scheduling of all shared ride van trips are coordinated on a shared ride basis according to pick-up and destination areas, appointment times and vehicle availability.
- ❖ Please be ready at least 15 minutes before your scheduled pick-up time.
- ❖ Remember to schedule all side trips (bank, drug store, etc.) when making your initial appointment.
- ❖ Be courteous to your driver and fellow passengers.
- ❖ STS is not responsible for articles left on the vehicle.
- ❖ No smoking, eating or drinking allowed.
- ❖ Service is not provided on Sunday or the following holidays: New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving, or Christmas day.
- ❖ Call STS to inquire about our escort policy procedure and requirements.
